

## **Notice of NIGC 2018-2022 Strategic Plan Consultation**

June 27, 2017

## Dear Tribal Leader:

On behalf of the National Indian Gaming Commission (NIGC or Commission), we invite you to participate in a multi-media consultation meeting on the NIGC 2018-2022 Strategic Plan. The consultation will be held on **July 13, 2017 from 1:00 pm to 4:00 pm Eastern Standard Time** and may be attended: (1) in person in Washington, D.C.; (2) telephonically; or (3) by video conference.

The NIGC recognizes and respects the sovereignty of Indian tribes and the government-to-government relationship that exists between the United States and tribal governments. Accordingly, the NIGC is committed to consultation that will implement Executive Order 13175, "Consultation and Coordination with Indian Tribal Governments."

The NIGC 2018-2022 Strategic Plan will be the framework that NIGC will use to focus agency efforts on a set of strategic goals. These draft strategic goals are as follows:

Strategic Goal 1: Gamesmanship – Protect against anything that amounts to gamesmanship on the backs of tribes through meaningful communication, training, and technical assistance and utilizing NIGC's enforcement authorities, when necessary.

Strategic Goal 2: Strong Workforce – Maintain a strong workforce both within the Agency as well as with NIGC's tribal regulatory partners.

Strategic Goal 3: Technology – Leverage reliable and emerging industry technology trends to support tribal economic development, self-sufficiency and the integrity of Indian gaming.

Strategic Goal 4: Rural Outreach – Develop and execute a plan for small rural gaming tribes that reviews training, technical assistance and regulations.

Strategic Goal 5: Operational Excellence – Deliver appropriate resources, solutions, and services in an efficient and effective manner to benefit stakeholders.
