Re: Review of Amended and Restated Credit Agreement for the Spokane Tribe of Indians

Dear Mr. Wheat:

This letter responds to your request of November 15, 2021, for the National Indian Gaming Commission's Office of General Counsel to review a credit agreement between the Spokane Tribe of Indians (Tribe) and U.S. Bank, National Association. Specifically, you have asked for my opinion whether the document is a management contract requiring the NIGC Chairman's approval under the Indian Gaming Regulatory Act (IGRA). You have also asked for my opinion whether the loan document violates IGRA's requirement that the Tribe have the sole proprietary interest in its gaming activity.

In my review, I considered the following submissions (the Loan Document) which is unexecuted, but represented to be in substantially final form:

- Amended and Restated Credit Agreement, marked in the upper right corner as "NIGC Draft 11/15/21" and at the bottom left corner as "4895-6559-3088\10".

The Loan Document contain terms similar to other agreements the Office of General Counsel has already reviewed and analyzed, which are available on the NIGC's website. Applying the same analysis here, it is my opinion that the Loan Document is not a management contract and does not require the approval of the NIGC Chairman. It is also my opinion that it does not violate IGRA's sole proprietary interest requirement.

It is my understanding that the draft is represented to be in substantially final form, and if the Loan Document changes in any material way prior to closing or is inconsistent with assumptions made herein, this opinion shall not apply. Further, this opinion is limited to the Loan Document listed above. This opinion does not include or extend to any other agreements not submitted for review.
